Hines Global Income Trust, Inc. (the "Company") acquired the remaining three buildings of the Bradley Business Center, on January 20, 2022. The Bradley Business Center is a mixed-use campus located in Chicago, Illinois. It is comprised of four buildings totaling approximately 467,000 square feet and is currently 97% leased to 21 tenants. The net purchase price of the Bradley Business Center is approximately \$97.3 million exclusive of transaction costs and closing prorations. The Company originally acquired the first of the four buildings in the Bradley Business Center in November 2021. The seller is not affiliated with the Company or its affiliates.
